WHEREAS, Vermillion County, Indiana, by and through its Board of Commissioners, is the holder of tax sale certificates on the properties described in Exhibit A attached hereto;

WHEREAS, pursuant to I.C. 6-1.1-24-9(d), the Vermillion County Board of Commissioners may assign tax sale certificate held in the name of the county executive to any political subdivision;


WHEREAS, the Vermillion County Redevelopment Commission has expressed a desire to obtain tax sale certificates on the properties described in Exhibit A; and

WHEREAS, it is a benefit to Vermillion County and its redevelopment that the tax sale certificates for the properties described in Exhibit A now be assigned to the Vermillion County Redevelopment Commission.


BE IT, THEREFORE, RESOLVED AS FOLLOWS:

1. Vermillion County, Indiana by and through its Board of Commissioners hereby approves the assignment of those tax sale certificates held by the county to the Vermillion County Redevelopment Commission for the properties described in Exhibit A attached hereto.
2. All taxes, penalties and assessments against the properties described herein shall be waived for the tax year 2017 payable 2018 and prior as to the City of Clinton, Indiana.
3. The period of redemption of the properties described herein shall be for one hundred twenty (120) days from the date the certificates are assigned pursuant to Indiana Code.
