

**RESOLUTION 2019- 6**  
**Vermillion County Council**

**TRANSFERRING ADMINISTRATION OF THE CONGRESSIONAL  
TOWNSHIP SCHOOL FUNDS TO THE INDIANA STATE TREASURER**

WHEREAS, Vermillion County currently maintains and administers certain monies known as the Congressional Township School Funds under the provisions of I.C. 20-42-2; and

WHEREAS, pursuant to I.C. 20-42-2-4.5, the Vermillion County Council desires to transfer custody of these funds to the Indiana State Treasurer to be held and administered by the Indiana Treasurer.

NOW, THEREFORE, be it RESOLVED by the Vermillion County Council that:

1. Custody of the following funds with the following balances shall be transferred to the Treasurer of the State of Indiana pursuant to I.C. 20-42-2-4.5:

Fund No. 1124 Congressional School Interest	\$49,854.32
Fund No. 1125 Congressional School Principal	\$3,202.08


2. Within ten days of the approval of this Resolution, the Vermillion County Auditor shall prepare and file with the Vermillion County Board of Commissioners a report showing the following:
  - a. The total amount of each fund that has been entrusted to and is held in trust by the County.
  - b. The total amount of each fund that is loaned as provided by law.
  - c. The total amount of each fund, if any, loaned to the County and that is not loaned.
  - d. The total amount of each fund held in cash in the possession and custody of the County and that is not loaned.
  - e. A separate schedule of past due loans.
3. The Vermillion County Board of Commissioners shall examine the report and, if found, correct, shall order:
  - a. The report be entered on its records; and
  - b. The Vermillion County Auditor to draw warrants, payable to the Treasurer of the State, for the amount of the funds that are not loaned and are held in cash in the custody and control of the County as shown on the report.
4. The County Auditor shall forward the warrants to the Treasurer of the State of Indiana together with a certified copy of the report and of this Resolution.






