## RESOLUTION No. 2010-<u>67</u> Vermillion County Board of Commissioners

## A RESOLUTION CONFIRMING THE CREATION OF THE NEWPORT CHEMICAL DEPOT MILITARY BASE RESUSE AREA

WHEREAS, the Newport Chemical Depot Reuse Authority ("Reuse Authority"), acting pursuant to I.C. 36-7-30-10, adopted Resolution No. 2010-1 on the 13th day of January, 2010, designating certain areas within Vermillion County to be an military base reuse area known as the Newport Chemical Depot Military Base Reuse Area;

WHEREAS, said Resolution further declared the entire Newport Chemical Depot Military Base Reuse Area to be an Allocation Area and established and adopted a Reuse Plan for the Newport Chemical Depot Military Base Reuse Area;

WHEREAS, IC 36-7-30-11(a) requires that a resolution designating a military base reuse area and establishing a reuse plan must be approved by the plan commission for the unit and on January 14, 2010, the Vermillion County Area Plan Commission adopted its Resolution 2010-1determining that the establishment of the Newport Chemical Depot Military Base Reuse Area and the Reuse Plan conform to the Comprehensive Plan for Vermillion County and approving the same;

WHEREAS, IC 36-7-30-11(b) requires that the determination that a geographic area is a military base reuse area must be approved by the legislative body for the unit and on February 2, 2010, the Vermillion County Board of Commissioners adopted its Resolution 2010-4 approving the designation and establishment of the Newport Chemical Depot Military Base Reuse Area, the Reuse Plan, and the declaration of the Area as an Allocation Area;

WHEREAS, the Reuse Authority posted and published notice in the *Daily Clintonian* of the adoption and substance of Resolution 2010-1, in accordance with IC 36-7-30-12 and IC 5-3-1, which notice also gave notice of a public hearing on the proposed Project to be held by the Reuse Authority;

WHEREAS, on March 4, 2010, the Reuse Authority conducted a public hearing at which time the Reuse Authority heard all persons interested in the proceedings and considered all written remonstrances and objections that were filed;

WHEREAS, the Reuse Authority, at the conclusion of the above-described public hearing, adopted Resolution 2010-2 confirming the declaration of the Newport Chemical Depot Military Base Reuse Area.

## NOW, THEREFORE, BE IT RESOLVED THAT:

 The Reuse Authority Resolution No. 2010-2 confirming the establishment of the Newport Chemical Depot Military Base Reuse Area, declaring the Area an Allocation Area and establishing an Reuse Plan for the Area is in all respects confirmed and approved.
