VERMILLION COUNTY, INDIANA BOARD OF COMMISSIONERS

**A RESOLUTION TO ASSIGN TAX SALE CERTIFICATES
TO THE CITY OF CLINTON, INDIANA**

WHEREAS, Vermillion County, Indiana, by and through its Board of Commissioners, is the holder of tax sale certificates on the properties described in Exhibit A attached hereto;

Whereas, pursuant to I.C. 6-1.1-24-9(d), the Vermillion County Board of Commissioners may assign tax sale certificate held in the name of the county executive to any political subdivision;

Whereas, the City of Clinton, Indiana has expressed a desire to obtain tax sale certificates on the properties described in Exhibit A and has filed with the Vermillion County Board of Commissioners an Application for Assignment of Tax Sale Certificates;;

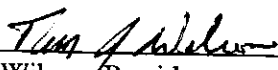
Whereas, the City of Clinton, Indiana, by its application, has presented to this Board of Commissioners its intentions with respect to the properties; and

Whereas, it is a benefit to both Vermillion County and the City of Clinton that the tax sale certificates for the properties described in Exhibit A now be assigned to the City of Clinton, Indiana.

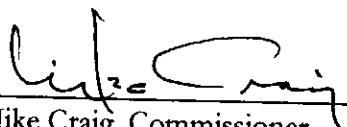
BE IT, THEREFORE, RESOLVED AS FOLLOWS:

1. That Vermillion County, Indiana by and through its Board of Commissioners hereby approves the assignment of those tax sale certificates held by the county to the City of Clinton, Indiana for the properties described in Exhibit A attached hereto.
2. That all taxes, penalties and assessments against the properties described herein shall be waived for the tax year 2010 payable 2011 and prior as to the City of Clinton, Indiana.
3. That the period of redemption of the properties described herein shall be for one hundred twenty (120) days from the date of this assignment pursuant to Indiana Code.

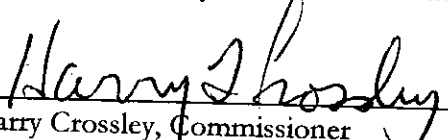
