RESOLUTION OF THE COUNTY COMMISSIONERS OF VERMILLION COUNTY, INDIANA, AUTHORIZING THE SUBMITTAL OF THE WDW APPLICATION TO THE INDIANA OFFICE OF COMMUNITY AND RURAL AFFAIRS AND ADDRESSING RELATED MATTERS

WHEREAS, the Commissioners Vermillion County, Indiana recognizes the need to stimulate growth and to maintain a sound economy within its corporate limits; and

WHEREAS, the Housing and Community Development Act of 1974, as amended, authorizes the Indiana Office of Community and Rural Affairs to provide grants to local units of government to meet the housing and community development needs of low- and moderate-income persons; and

WHEREAS, Vermillion County, Indiana has conducted or will conduct public hearings prior to the submission of an application to the Indiana Office of Community and Rural Affairs, said public hearings to assess the housing, public facilities and economic needs of its low- and moderate-income residents;

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of Vermillion County, Indiana that:

- 1. The County Commission President is authorized to prepare and submit an application for grant funding to address Water Issues within the Hillsdale Water Corporation's water service area, and to execute and administer a resultant grant including requisite general administration and project management, contracts and agreements pursuant to regulations of the Indiana Office of Community and Rural Affairs and the United States Department of Housing and Urban Development.
- 2. The Hillsdale Water Corporation will be committing the local match for the project and hereby commits the requisite local funds in the amount of One Million, One Hundred Eighty Five Thousand, Five Hundred Dollars and Zero Cents (\$1,185,500.00), in the forms of the following: (1) \$1,163,500 from the USDA Rural Development low interest loan program, (2) \$19,000 from previously paid preliminary engineering and (3) \$3,000 from previously paid environmental review, as matching funds for said program, such commitment to be contingent upon receipt of WDW funding from the Indiana Office of Community and Rural Affairs.
