ORDINANCE VACATING A PUBLIC WAY:

WITNESSETH:

WHEREAS, Erik and Janis Ingebrigtsen are the owners of Lots 22, 23, 24, 25, and 26 in the Town of West Clinton Junction, Vermillion County, Indiana, and

WHEREAS, Erik and Janis Ingebrigtsen are the owners of Lots 27, 28, 29, 30, and 31 in the Town of West Clinton Junction, Vermillion County, Indiana, and

WHEREAS, pursuant to I.C. 36-7-3-12(b)(3) petitioners Erik and Janis Ingebrigtsen have shown that they are the only owners of land abutting the public way to be vacated, and

WHEREAS, There is a dedicated Fourteen foot (14') wide east-west public way (alley) dividing Lots 27-31 from Lots 22-26 and running south 300 feet from the south edge of Sixth Street to the north end of Lots 22 and 31 in the aforesaid addition, and

WHEREAS, That the aforesaid Fourteen foot (14') wide property is not now, nor to the knowledge of the undersigned County Commissioners, ever been improved or otherwise used for a public way, and

WHEREAS, Erik and Janis Ingebrigtsen, the petitioners herein, have requested that the aforesaid public way be vacated and seven feet (7') of even width off of the east side of said public way, be added to the west side of Lots 27-31 and seven feet (7') of even width off of the west side of said public

way, be added to the east side of Lots 22-26, and

WHEREAS, The vacating of the public way would not hinder the growth or orderly development of the Town West Clinton Junction or neighborhood, and

WHEREAS, the vacating of the public way, would not hinder access to the land of any other person nor access to any church, school, cemetery or other public building or place.

THEREFORE, the Board of Commissioners of Vermillion County in a duly advertised meeting and action NOW ORDAINS as follows:

- 1. That the dedicated fourteen foot (14') wide east-west public way, dividing Lots 27-31 from Lots 22-26 and running south 300 from the north edge of Sixth Street to the south end of Lots 22 and 31 in the Town of West Clinton Junction, Vermillion County. Indiana, is hereby vacated as a public way.
- 2. That the East one-half, being seven feet (7') of even width of the vacated public way, be added, by operation of law, to the west side of Lots 27-31 and the west one-half, being seven feet (7') of even width of the vacated public way, be added, by operation of law, to the east side of Lots 22-26 as laid out and platted on May 31, 1911 and as shown in Deed Record 54, Page 116 in the office of the Recorder of Vermillion County, Indiana.
- 3. That upon passage of this Ordinance, Lots 22, 23, 24, 25, and 26 and Lots 27, 28, 29, 30, and 31 in the Town of West Clinton Junction, Vermillion County are extended, by operation of law, to include their

proportionate part of the public way (alley) vacated as set forth above.

4. That pursuant to I.C. 36-7-3-12(e), the Auditor of the Vermillion County, Indiana, shall transfer the aforesaid vacated alley on the Auditor's records to Erik and Janis Ingebrigtsen, husband and wife, 2108 N. 10th St., Terre Haute, IN 47804, as hereinabove set forth and shall furnish a duly signed copy of this Vacating Ordinance to the Vermillion County Recorder for recording, who in turn, upon recording, shall deliver said copy, forthwith to: Erik and Janis Ingebrigtsen, 2108 N. 10th St., Terre Haute, IN, 47804.
