RESOLUTION OF THE COUNTY COMMISSIONERS OF VERMILLION COUNTY, INDIANA, AUTHORIZING THE SUBMITTAL OF THE WDW APPLICATION TO THE INDIANA OFFICE OF COMMUNITY AND RURAL AFFAIRS AND ADDRESSING RELATED MATTERS

WHEREAS, the Commissioners Vermillion County, Indiana recognizes the need to stimulate growth and to maintain a sound economy within its corporate limits; and

WHEREAS, the Housing and Community Development Act of 1974, as amended, authorizes the Indiana Office of Community and Rural Affairs to provide grants to local units of government to meet the housing and community development needs of low- and moderate-income persons; and

The <u>Hillsdale Water Corporation will be committing the local match for the project</u> and hereby commits the requisite local funds in the amount of Nine Hundred Ninety-Six Thousand Dollars and Zero Cents (\$996,000.00), in the forms of the following: (1) \$996,000.00 in State Revolving Fund (SRF) low interest loan dollars as matching funds for said program, such commitment to be contingent upon receipt of WDW funding from the Indiana Office of Community and Rural Affairs.
