A RESOLUTION TO ACCEPT TAX SALE CERTIFICATES
FROM VERMILLION COUNTY, INDIANA BY AND THROUGH ITS BOARD OF COMMISSIONERS

WHEREAS, Vermillion County, Indiana, by and through its Board of Commissioners, is the holder of tax sale certificates on the properties described in Exhibit A attached hereto;

Whereas, pursuant to I.C. 6-1.1-24-9(d), the Vermillion County Board of Commissioners may assign tax sale certificate held in the name of the county executive to any political subdivision;

Whereas, the City of Clinton, Indiana has expressed a desire to obtain tax sale certificates on the properties described in Exhibit A and has filed with the Vermillion County Board of Commissioners an Application for Assignment of Tax Sale Certificates;


Whereas, the City of Clinton, Indiana, by its application, has presented to this Board of Commissioners its intentions with respect to the properties; and


Whereas, it is a benefit to both Vermillion County and the City of Clinton that the tax sale certificates for the properties described in Exhibit A now be assigned to and accepted by the City of Clinton, Indiana.

BE IT, THEREFORE, RESOLVED AS FOLLOWS:

1. That the City of Clinton, Indiana, by and through its Board of Public Works and Safety, hereby approves and accepts the assignment of those tax sale certificates held by the Vermillion County Board of Commissioners for those properties described in Exhibit A attached hereto.
2. That all taxes, penalties and assessments against the properties described herein were waived for the tax year 2017 payable 2018 and prior as to the City of Clinton, Indiana.
3. That the period of redemption of the properties described herein shall be for one hundred twenty (120) days from the date of the assignment pursuant to Indiana Code.
