**ORDINANCE ON JOHN P. PIKE AND PAMELA M. PIKE'S  
PETITION TO VACATE PUBLIC WAY**

Comes now John P. Pike and Pamela M. Pike at a regular meeting held on the 20th day of August, 2019. Vermillion County Commissioners, having reviewed John P. Pike and Pamela M. Pike's Petition to Vacate Public Way filed the July 17, 2019. The same having been published pursuant to the request of I.C. 5-3-1 and mailed by certified mail to all owners whose property abuts the property proposed to be vacated (if any).

WHEREAS, John P. Pike and Pamela M. Pike own(s) the following described real estate in Hillsdale, Vermillion, Indiana, described to-wit:

**Lots Numbered 14, 15, 16, 17, 18, 19, 31, 32, 33 & 34 in the Original Plat of the Town of Alta, Vermillion, County, Indiana.**
